online fundraising campaign, Saving Lives. The three-month campaign focussed on attracting donations that would help us to continue delivering SVSG support services to those most in need. Priority areas for the donations were the Campus of Hope, SVSG Helpline, and increasing the number of case management staff. It didn't take long for the community to show their love and support for the work of SVSG.

Thank you to our long-term supporters, Robert and Lote Scanlan Silivelio and Imoamaua Avei who set up a cupcake stall at the front of SVSG' office. Over a 6-week period, they baked and sold hundreds of cupcakes and donated proceeds to the campaign.

In May and June, we opened 63 new cases, received 393 Helpline calls, and cared for an additional five (5) children who were referred to the Campus of Hope. We continued to deliver rehabilitation programs for offenders of violence referred by the Family Courts. Our advocacy and community awareness work included hosting a session on SVSG support services to more than 100 youths of the Church of Jesus Christ of the Latter Day Saints from Nu'umau Stake Sauniatu. Just before Mother's Day, we were blessed with the arrival of a new-born baby who is under the care and protection of SVSG.

Thank you Ms. Donna Webb, a Child Protection Specialist from Australia, for conducting a workshop with staff and volunteers as part of the review of SVSG's Child Protection Policy. This review is part of the Samoa Gender Partnership Program of the Tautua - Human Development for All Program, an initiative of the Governments of Australia and Samoa

Community awarenessraising & advocacy

More than 100 youths of the Church of Jesus Christ of the Latter Day Saints from the Nu'umau Stake Sauniatu, gathered for an awareness session on the support services offered by the Samoa Victim Support Group.

The awareness program forms part of the Youth Camp for adolescents 12 - 18 years old. We are grateful to the community for taking the initiative to raise awareness on gender-based violence, and how we, as a collective, can work together to address it.



Rehabilitation programs

Forty-nine (49) offenders of violence referred to us from the Family Court attended rehabilitation programs SVSG offices in Apia and Tuasivi (Savai'i) that take place every Monday to Thursday.





EVE research project: The Evidence for Violence Prevention in the Extreme (the EVE Project) is a research study conducted in partnership with local villages to develop an indigenous approach to preventing violence against women in partnership with the University College of London. During May and June, the project trained the EVE project coordinators who implement the initiative within the selected villages. The project also held a two-day community intervention event at Faleasi'u. This highly successful event was attended by community leaders, including speakers, reverends, dignitaries, and the wives of these individuals.

Empowered Nofotane women: The Nofotane shop has opened at the Sheraton Hotel at Mulifanua. Thank you to to Sheraton Management for believing in the empowerment of Nofotane women. Another higlight was the visit by Hastings Mayor Sandra Hazlehurst and her delegation from New Zealand to one of the Nofotane market stalls. She was assisted by our wonderful volunteer, Victoria Solomona, a young woman survivor of violence and a former resident of the SVSG shelter refuge some 10 years ago. Victoria's volunteer work for SVSG is her way of giving back to the community, through advocating and promoting the economic empowerment of women survivors of violence.

Samoa Government financing assistance towards eliminating violence against women and girls: SVSG submitted the final project report to the Government of Samoa in June. This Government funding supported counselling, legal information brochures, advocacy programs for male leaders and young boys, Campus of Hope shelters, child labour (vendors), and welfare assistance. One key project highlight was remvoing 45 child vendors aged 6 to 15 years from the streets and enrolling them in five primary schools.

Samoa Gender Partnership Program: Forty (40) leading SVSG village representatives in Savaii received a two-day training on their role as first respondents to cases of genderbased violence in their communities. This is either through referrals from the Helpline, or referrals from members of their communities. Elderly village representatives made up the majority of the participants to the Savaii training. The targeted training is part of the activities implemented by SVSG through a project supported by the Tautua Program, a partnership between the Government of Samoa and Australia.



Examples of cases and helpline calls

Child abuse case: A concerned informant reported a distressing case of child abuse that had persisted for years. The informant provided explicit details regarding the ongoing mistreatment of the children involved, and tragically, the abuse had occurred again on the day of the report. In response, immediate action was taken, with the case being referred to the police for thorough investigation and assistance. As a result, the victims were promptly brought in to provide statements, and they were admitted to the Campus of Hope on the very same day.

General assistance case: A father of one child approached our office seeking assistance. He disclosed that he was prohibited from residing in his village due to his struggles with alcoholism. It was suggested that he relocate to his maternal family's residence, which he consented to, and the matter was resolved. This instance highlights the importance of community support and understanding in helping to address personal challenges such as alcoholism. By offering alternative solutions and facilitating a supportive environ-ment, individuals can find help to overcome difficult situations and rebuild their lives. **Domestic violence case:** A mother of two children sought assistance through the Helpline. She stated that she had been abused and subjected to insulting words by her husband, who also had a drug problem. Due to the unsafe environment, she came to SVSG for help. Case officers promptly addressed the situation, and she was provided with shelter the next day. An interim Protection Order was prepared to ensure her safety while she was at the Sakura House, awaiting further legal proceedings.

General assistance case: The women arrived at the office seeking assistance for herself and her daughter. She asked for help in putting an end to her daughter's involvement in an inappropriate relationship with her own uncle. SVSG reported the matter to the police. The SVSG team then provided the applicant with the necessary information to present her case before the village council. The complaint was resolved through the collaborative efforts of the police and the SVSG member, resulting in the victim's satisfaction and subsequent return home. Helpline call: A concerned principal reached out to our helpline to report a sexual assault case. We promptly took action and referred the case to the Police Criminal Investigation Division (CID) for further investigation. To ensure the safety of the victim, she was immediately admitted to our shelter where she could find refuge and support during this difficult time.

Helpline call: We received another distressing call through our helpline regarding a case of child abuse. The informant bravely reported an ongoing history of abuse that had been occurring for several years. She provided crucial details about the respondent's abusive behavior towards the children. Disturbingly, the abuse had occurred again on the day of the report. Without delay, we referred the case to the police for a thorough investigation and necessary assistance. The victims were promptly brought in to provide their statements, and on the same day, they were admitted to our Campus of Hope, where they could begin their journey of healing and recovery in a safe and supportive environment.

Helpline call: An informant reported a case of child abuse by a neighbor. The matter was subsequently handled by Faleolo Police Post who issued a warning to the parents for their neglectful behavior of leaving their children at home and subjecting them to abuse.

The duo were truly touched by the children's gift of song that was sung at the end of the visit. Lesa and Livingstone are looking forward to their next visit to the Campus.



Digicel's Samoa's Change Maker's Day: Each year on the 5th of June, Digicel Samoa staff volunteer their time to make positive changes in the community. Fia'ailetoa Pepe Christian Fruean, Chair of Digicel Samoa, came along with management and staff to do gardening at the Campus grounds and a general clean up. Some of the staff also got to meet with the children.



Mapu Maia Delegation from New Zealand: The children turned their temporary safe haven into a traditional village setting, to officially welcome the Mapu Maia delegation from New Zealand. The delegation led by their CEO, Mrs Pesio Ah Honi, included counsellors and health promoters.



Longtime friends of the Campus visit the children: Sam Atoa, his wife and their team have been supporting SVSG for a long time. They travelled from Utah to visit our lovely island of Samoa and made time to bring gifts for the children and provide assistance for our ongoing fundraising efforts for shelter maintenence.
